

## REQUIREMENTS FOR HANDS-ON PARTICIPATION

Each hands-on workshop will provide healthcare professionals with an intensive immersion into the art and science of facial aesthetics and therapeutics. This is whether you do or do not intend to inject a live patient. All attendees will be provided with a mannekin (foam) head and disposable syringes and needles. These are yours to use and take back to your office after the programs. You may simulate the injections at the appropriate sites on the foam head as well as use a fine marker to mark all the sites with doses. Attendees will also have the opportunity to simulate “dry” injections at all the injection sites on other attendees as well as model patients under supervision of an instructor. This will provide all attendees with a full understanding of when, how, and how much to inject without having to wait 2 weeks to see the outcome. Every attendee has to physically demonstrate the technique for all sites to an instructor before completion.

### LIVE PATIENT INJECTING

Bring your model and your FDA-approved, injectable agents (invoice from a valid US distributor) to learn advanced injection techniques from the experts.

Injectables and Medical Supplies: you may use any USA FDA approved HA products (Juvederm or Restylane injectable products), as well as Botox, Xeomin or Dysport. **To inject in the LIVE PATIENT DENTOX WORKSHOP, it is mandatory that you provide us with the following qualifying documents AT LEAST 1 WEEK BEFORE THE WORKSHOP. #### Mandatory Documents For Live Patient injecting

- A copy of your current State Medical, Dental or other healthcare provider license (and Registration, if your state requires one). Your photo ID must be presented at the workshop that matches your license.
- A copy of your current professional liability insurance. Confirm with your insurer that you have coverage for the procedures you wish to perform
- Supervisory Physician Acknowledgement Form (If you are a nurse, nurse practitioner, physician assistant or other nurse wishing to inject during the Hands-On Session, you must provide us with a signed acknowledgement from your Supervisory Physician).

Please note: if you do not provide us with these Mandatory Documents, you will not be able to inject in the Workshop.

### INJECTABLE PRODUCT REQUIREMENTS

- Attendees are responsible for bringing their own product(s) for injecting during the hands-on session Attendees who plan on injecting during the hands-on training are required to bring the following supplies to the workshop (quantities are suggested; the needs of your consenting model's case may require adjustment of quantities):

Injectable agents (can be purchased from Allergan, or secured for you by Dentox with 10 days advanced notice) –

- 1 vial of neurotoxin
- 1-2 syringes of the dermal filler of choice

Please let us know in advance whether you would like us to bring the following materials for you to use at the program.

4 – 3 cc syringes

4 – 1 cc syringes

2 or 3 – 18-21 gauge needles

4 – 30 gauge, ½ in needles

1 bottle of saline solution for product reconstitution

4 sets of powder-free latex gloves

A handful of alcohol swabs and sterile gauze

Lidocaine with and without epinephrine

Topical anesthetic of injector's choice (Dentox recommends BLT= Benzocaine 20% Lidocaine 6% Tetracaine 4%)

Cosmetic facial pencil for marking injection points
